BASE / CARRIER: Labdanum Resin (Cistus) and other resinous/balsamic materials blended into Sandalwood Oil base — “Amber” is a composed oriental accord, not a single botanical source

CAS No.: 8016-26-0 (Labdanum Resin component) — blended with other resins in Sandalwood Oil base

Composition Transparency Note: “Amber” has no single botanical or animal source. In perfumery, it refers to a composed oriental accord traditionally built from labdanum resin (Cistus), benzoin, vanilla-type notes, and other balsamic/resinous materials. This attar’s amber character is achieved as a resin blend in a Sandalwood Oil base, not from fossil amber (Pinus succinifera) or ambergris (whale-derived). No animal-derived materials are used.
