### SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

**Eye Contact:** Irritation will occur with possible damage

**Skin Contact:** May cause irritation upon prolonged exposure. Fruity ester-type aroma chemicals may cause sensitisation in susceptible individuals — patch test before skin use.

**Safe Handling:** Avoid ingestion. Follow good industrial hygiene practices. Wear eye protection, gloves and aprons. Ventilate area well. Keep away from heat, sparks, and open flames. Keep out of reach of children and pets — sweet berry aroma is attractive.

**Storage Requirements:** Store in an area that is cool, dry, and well-ventilated. Do not expose to temperatures over 30°C. Keep away from direct sunlight to preserve the fresh, sweet blueberry character. Keep tightly sealed.
