Safe Handling: Avoid ingestion. Follow good industrial hygiene practices. Wear eye protection, gloves and aprons. Ventilate area well. Always dilute before topical application.

Storage Requirements: Store in an area that is cool, dry, and well-ventilated. Do not expose to temperatures over 25°C. Keep tightly sealed in dark glass containers away from light. Cedarwood oil is a natural fixative with excellent stability.
