Widely used in outdoor products and air fresheners. Note: Lower flash point. Does NOT contain actual citronella EO or any controlled substances.

SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

Eye Contact: Irritation will occur with possible damage

Skin Contact: May cause irritation upon prolonged exposure. Contains aroma chemicals which may cause sensitisation — patch test before first skin application.

Inhalation: If inhalation causes irritation, supply fresh air. Avoid concentrated inhalation; use in well-ventilated spaces.

Ingestion: Rinse out mouth and drink plenty of water. NOT FOR INTERNAL USE.
