SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

Eye Contact: Irritation will occur with possible damage

Skin Contact: May cause irritation upon prolonged exposure. Resinous and labdanum-type aroma chemicals are known potential sensitizers — patch test is essential before first skin application.

Ingestion: Rinse out mouth and drink plenty of water. NOT FOR INTERNAL USE.

Skin: Remove contaminated clothing. Wash with soap and flush with plenty of water. Note: warm amber colour may stain skin and light fabrics — use oil-based cleanser if colour persists. Seek medical attention if reaction develops.

Ingestion: Administer water or milk to dilute. Seek medical attention immediately or call a poison control center.

Inhalation: Avoid gross inhalation of fumes. Remove to fresh air and seek medical attention if needed.

- Large spills: absorb onto non-flammable absorbent. Wash area with soap and water.

Safe Handling: Avoid ingestion. Follow good industrial hygiene practices. Wear eye protection, gloves and aprons. Ventilate area well. Keep away from heat, sparks, and open flames. Handle with care — warm amber colour may stain clothing and surfaces.

Storage Requirements: Store in an area that is cool, dry, and well-ventilated. Do not expose to temperatures over 30°C. Keep away from direct sunlight — UV exposure may alter the rich amber-resinous character. Keep tightly sealed.

Use sparingly — excellent longevity means a small amount goes a very long way.
