Evocative of walking through a pine and cedar forest after rain — primal, grounding, and deeply calming. Does NOT contain actual cedarwood EO, pine EO, vetiver EO, or any controlled substances.

SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

Eye Contact: Irritation will occur with possible damage

Skin Contact: May cause irritation upon prolonged exposure. Contains cedarwood-type (cedrol, atlantone) and pine-type (alpha-pinene analogue) aroma chemicals which may cause sensitisation in susceptible individuals — patch test before first skin application.

Inhalation: If inhalation causes irritation, supply fresh air. Deep, resinous woody fragrance — avoid concentrated inhalation; use in well-ventilated spaces.
