SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

Eye Contact: Irritation will occur with possible damage

Skin Contact: May cause irritation upon prolonged exposure. Contains jasmine-type and ylang ylang-type aroma chemicals which are known potential sensitizers — patch test is recommended before first skin application. This is a rich, intense floral fragrance — use sparingly.

Inhalation: If inhalation causes irritation, supply fresh air. Rich, sweet tropical floral fragrance — avoid concentrated inhalation; always use in well-ventilated spaces. Extremely potent fragrance at high concentrations.

Ingestion: Rinse out mouth and drink plenty of water. NOT FOR INTERNAL USE.

Eyes: Flush with plenty of water or eyewash solution for 15 minutes. Get immediate medical attention.

Methods for Cleaning Up: Eliminate all sources of ignition. Ventilate area thoroughly. Prevent liquid from entering sewers.

- Small spills: wipe up with paper rags (place in closed metal waste container)
- Large spills: absorb onto non-flammable absorbent. Wash area with soap and water.

SECTION 7: HANDLING AND STORAGE

Safe Handling: Avoid ingestion. Follow good industrial hygiene practices. Wear eye protection, gloves and aprons. Always use in well-ventilated areas — Frangipani is one of the most intensely sweet tropical fragrances; concentrated exposure may cause headache in sensitive individuals. Keep away from heat, sparks, and open flames. Keep tightly sealed at all times.

Storage Requirements: Store in an area that is cool, dry, and well-ventilated. Do not expose to temperatures over 30°C. Keep away from direct sunlight to preserve the delicate exotic floral character. Keep tightly sealed — the fragrance is highly pervasive.
