*CARRIER OIL — FOR EXTERNAL / COSMETIC USE. Golden Jojoba Oil is a premium cold-pressed liquid wax ester extracted from the seeds of Simmondsia chinensis. Technically a liquid wax (not a true triglyceride oil), it is uniquely similar to human skin sebum — making it one of the most skin-compatible and widely used carrier oils in cosmetics, aromatherapy, and personal care. Rich in eicosenoic acid (gadoleic acid ~71%), docosenoic acid (erucic acid ~14%), and oleic acid (~10%). Naturally long shelf life due to wax ester structure. NON-COMEDOGENIC. Suitable for all skin types. Does NOT contain allergens or controlled substances.

SECTION 3: HAZARD IDENTIFICATION

This material is not classified as hazardous under GHS/CLP criteria. The toxicological properties have not been fully investigated.

Eye Contact: May cause mild irritation. Flush with water if contact occurs.

Skin Contact: Generally well tolerated. May cause sensitisation in individuals with nut/seed allergies — patch test before use.

Inhalation: Not expected to present an inhalation hazard under normal conditions of use.

Ingestion: NOT FOR INTERNAL USE as a supplement without professional guidance. If ingested in large quantities, seek medical advice.

SECTION 4: FIRST AID MEASURES

Eyes: Flush with plenty of clean water for 15 minutes. Seek medical attention if irritation persists.

Inhalation: Remove to fresh air. Seek medical attention if discomfort persists.

SECTION 5: FIRE AND EXPLOSION DATA

Flash Point (Method Used): >210°C Closed Cup

Auto-Ignition Temperature: Not established

Extinguishing Media: Dry Chemical, Carbon Dioxide, Foam

Unsuitable Media: Water jet — may spread fire

Special Firefighting Procedures: Fire fighters should wear positive pressure self-contained breathing apparatus.

Unusual Fire & Explosion Hazards: Not established. High flash point — low fire risk under normal storage conditions.

SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal Protection: Follow good industrial hygiene practices. Wear gloves and eye protection.

Methods for Cleaning Up: Absorb spill with absorbent material (sand, earth, vermiculite). Place in suitable closed container.

- Small spills: wipe up with paper rags or absorbent material
- Large spills: absorb onto non-flammable absorbent. Prevent entry into drains and waterways.

SECTION 7: HANDLING AND STORAGE

Safe Handling: Follow good personal hygiene practices. Keep away from heat and ignition sources. Avoid contamination.

Storage Requirements: Store in a cool, dry, dark, well-ventilated area below 25°C. Keep away from direct sunlight, heat, and strong oxidising agents. Keep tightly sealed. Refrigerate after opening where possible. Use amber or dark glass containers for storage.

SECTION 8: EXPOSURE CONTROL / PERSONAL PROTECTION

Threshold Limit Value: Not established

Respiratory: Not required under normal conditions of use

Ventilation: Normal ambient ventilation is adequate

Eye: Safety glasses recommended when handling bulk quantities

Skin: Gloves recommended for individuals with known nut/seed allergies

Physical State: Liquid, Oil

Color: Golden Yellow, Clear Liquid

Odor: Mild characteristic jojoba — slight nutty, waxy undertone; technically a liquid wax ester (not a true oil); lightweight, non-greasy, skin-identical structure

Vapor Pressure (mmHg.): Negligible at ambient temperature

Flash Point: >210°C (Closed Cup)

Boiling Point: > 300°C (decomposes)

Melting Point: Liquid at room temperature

Density @25°C: 0.868

Refractive Index @25°C: 1.466

Solubility in Water: Insoluble in water; miscible with other carrier oils and mineral oil

SECTION 10: STABILITY AND REACTIVITY

Stability: Stable under recommended storage conditions. Susceptible to oxidative rancidity on prolonged exposure to air, heat, and light.

Incompatibility (Materials to Avoid): Strong oxidising agents, strong acids, strong bases.

Conditions to Avoid: Heat, light, air exposure, moisture contamination.

Hazardous Decomposition By-products: Carbon monoxide, carbon dioxide, and acrolein may form during combustion.

Hazardous Polymerization: Will Not Occur

SECTION 11: TOXICOLOGICAL INFORMATION

CAUTION: FOR EXTERNAL USE ONLY. Not for internal use as a supplement. Patch test before use. Generally very well tolerated — one of the safest carrier oils. Store away from heat and light to prevent oxidation. Keep out of reach of children.

Acute Toxicity: Not classified as acutely toxic

Skin Irritation: Not classified as a skin irritant under normal conditions

Sensitization: May cause allergic reaction in individuals with known nut/seed allergies — patch test recommended before first use

Eye Irritation: May cause mild irritation

Chronic Effects: Not established

Note: Although this is a natural vegetable carrier oil, always conduct a patch test before use particularly if the user has known nut, seed, or plant allergies.

SECTION 12: ECOLOGICAL INFORMATION

Toxicity: Not expected to be harmful to aquatic organisms at low concentrations. Large spills should be prevented from entering waterways.

Biodegradability: Readily biodegradable — natural vegetable oil.

SECTION 13: DISPOSAL CONSIDERATION

Waste Disposal Methods: Dispose of in accordance with local, state, and federal regulations. Do not pour large quantities down drains — may cause blockages. Small quantities may be composted or disposed via licensed waste contractor.

SECTION 14: OTHER REGULATORY INFORMATION

Classification: Not classified as hazardous under GHS/CLP

Cosmetic Use: Approved for cosmetic and personal care use as a carrier/base oil

Food Grade Status: Cold pressed grade; NOT certified food grade — for external/cosmetic use only unless specifically stated

Hazards: Not classified as hazardous

Risk Phrases: Not classified as hazardous. Generally very well tolerated. Prevent large spills from entering waterways.

Safety Phrases: For external use only. Patch test before first use. Store in cool, dark conditions. Keep tightly sealed. Keep out of reach of children.
