### SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

**Eye Contact:** Irritation will occur with possible staining. Flush immediately with water.

**Skin Contact:** May cause irritation and staining upon contact. Wash immediately with soap and water.

- Large spills: absorb onto non-flammable absorbent. Wash area with soap and water.

**Safe Handling:** Avoid contact with skin, eyes and clothing — dye will stain. Use gloves and protective clothing. Avoid ingestion. Ventilate area well. Keep away from open flame.

**Storage Requirements:** Store in a cool, dry, well-ventilated area. Do not expose to temperatures over 30°C. Keep containers tightly sealed. Keep away from direct sunlight to preserve colour integrity.
