Eye Contact: Irritation will occur with possible damage.

Skin Contact: May cause irritation upon prolonged exposure. Always dilute before skin application if concentrated.

Inhalation: If inhalation causes irritation, supply fresh air.

Ingestion: Rinse out mouth and drink plenty of water. NOT FOR INTERNAL USE.
