### SECTION 3: HAZARD IDENTIFICATION

- Large spills: absorb onto non-flammable absorbent. Wash area with soap and water.

## SECTION 7: HANDLING AND STORAGE

**Safe Handling:** Avoid ingestion. Follow good industrial hygiene practices. Wear eye protection, gloves and aprons. Always dilute before topical application — maximum 0.7% in finished products. Jasmine absolute is one of the most potent floral absolutes — a little goes a very long way.

**Storage Requirements:** Store in an area that is cool, dry, and well-ventilated. Do not expose to temperatures over 25°C. Keep tightly sealed in dark glass containers away from light and heat. Jasmine absolute may partially solidify at low temperatures — gently warm before use. Quality should be verified after 24 months storage.
