Sourcing Transparency Note: True steam-distilled jasmine essential oil is not commercially viable at practical scale (extremely low yield). Genuine jasmine perfumery materials are typically produced via solvent-extracted absolute or are composed fragrance blends built from natural isolates and/or synthetic aromatics. This attar's jasmine character is achieved accordingly, blended into a Sandalwood Oil base. Batch-specific GC-MS is recommended to verify natural absolute content.
