Note the finished attar itself has no single CAS number (it is a flower distillate suspended in an oil base), but the manufacturer discloses the specific Kewda Oil component CAS: 91770-47-7. GC-identified major constituents: 2-Phenylethyl Methyl Ether, Terpinen-4-ol, α -Terpineol, 2-Phenylethanol, Benzyl Benzoate, Germacrene B — these are recognized markers of genuine Pandanus flower oil in published perfumery literature.
