Known as "Nargis" in Hindi/Urdu (narayana — the eyes of the beloved), this fragrance captures the sweet, intensely floral, slightly green and powdery character of the narcissus bloom with jasmine and hyacinth undertones and a clean white musk base. Romantically poetic, intoxicating, and timeless. Does NOT contain actual narcissus absolute or any controlled substances.

### SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

**Eye Contact:** Irritation will occur with possible damage

**Skin Contact:** May cause irritation upon prolonged exposure. Contains narcissus-type and jasmine-type aroma chemicals which are known potential sensitizers — patch test before first skin application. Narcissus-type compounds may cause sensitisation in susceptible individuals.

**Inhalation:** If inhalation causes irritation, supply fresh air. Intensely sweet, heady floral fragrance — avoid concentrated inhalation; use in well-ventilated spaces.

**Ingestion:** Rinse out mouth and drink plenty of water. NOT FOR INTERNAL USE.

**Eyes:** Flush with plenty of water or eyewash solution for 15 minutes. Get immediate medical attention.
