### SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

**Eye Contact:** Irritation will occur with possible damage

**Eyes:** Flush with plenty of water or eyewash solution for 15 minutes. Get immediate medical attention.
