Ideal for candles, soaps, bath bombs, diffusers, personal care, and home fragrance applications. Does NOT contain actual raspberry extract, juice, seeds, or any controlled substances. NOT FOR INTERNAL CONSUMPTION despite its food-like fruity aroma.

SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

Eye Contact: Irritation will occur with possible damage

Skin Contact: May cause irritation upon prolonged exposure. Fruity ester and ionone-type aroma chemicals may cause sensitisation in susceptible individuals — always patch test before first skin application.

Eyes: Flush with plenty of water or eyewash solution for 15 minutes. Get immediate medical attention.

Safe Handling: Avoid ingestion. Follow good industrial hygiene practices. Wear eye protection, gloves and aprons. Ventilate area well. Keep away from heat, sparks, and open flames. Keep out of reach of children and pets at all times.

Storage Requirements: Store in an area that is cool, dry, and well-ventilated. Do not expose to temperatures over 30°C. Keep away from direct sunlight to preserve the fresh, bright raspberry character. Keep tightly sealed.
