Composition contains synthetic aroma chemicals and/or nature-identical ingredients blended to recreate the sharp, fresh, invigorating fragrance of Rosemary (Rosmarinus officinalis / Salvia rosmarinus) — a classic Mediterranean herb renowned in aromatherapy for its clarifying, stimulating, and mentally uplifting properties. A crisp, camphoraceous, herbal-green accord with eucalyptus freshness, a hint of peppermint, and a clean woody base. Widely used in personal care, hair care, soaps, candles, and diffusers. Note: Lower flash point — handle with extra care. Does NOT contain actual rosemary EO or any controlled substances.

SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

Eye Contact: Irritation will occur with possible damage

Skin Contact: May cause irritation upon prolonged exposure. Contains camphoraceous (1,8-cineole type) and alpha-pinene type aroma chemicals — patch test before skin application. Never apply undiluted. Lower flash point — handle with extra care.

Inhalation: If inhalation causes irritation, supply fresh air. Sharp, camphoraceous herbal fragrance — avoid concentrated inhalation. Do NOT apply near the face of infants or children under 10 years — camphoraceous components can cause respiratory distress.

Ingestion: Rinse out mouth and drink plenty of water. NOT FOR INTERNAL USE.

Eyes: Flush with plenty of water or eyewash solution for 15 minutes. Get immediate medical attention.

Skin: Remove contaminated clothing immediately. Wash skin thoroughly with soap and flush with plenty of water. Seek medical attention if irritation or allergic reaction develops.

Ingestion: Administer water or milk to dilute. Seek medical attention immediately or call a poison control center.

SECTION 5: FIRE AND EXPLOSION DATA

Flash Point (Method Used): >52°C Closed Cup — LOWER THAN MOST FRAGRANCE OILS; handle with extra care

Extinguishing Media: Dry Chemical, Carbon Dioxide, Foam

Unsuitable Media: Water (except to cool containers)

Special Firefighting Procedures: Fire fighters should wear positive pressure self-contained breathing apparatus. Low flash point — keep away from ALL ignition sources.

SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal Protection: Avoid ingestion. Wear eye protection, gloves and aprons. Ventilate area immediately. Eliminate ALL ignition sources — lower flash point.

Methods for Cleaning Up: Eliminate all sources of ignition immediately. Ventilate area thoroughly. Prevent liquid from entering sewers.

- Small spills: wipe up with paper rags (place in closed metal waste container)
- Large spills: absorb onto non-flammable absorbent. Wash area with soap and water.

SECTION 7: HANDLING AND STORAGE

Safe Handling: Avoid ingestion. Wear eye protection, gloves and aprons. Ventilate area well. Keep well away from all heat, sparks, and open flames — lower flash point than most fragrance oils.

Storage Requirements: Store in an area that is cool, dry, and well-ventilated. Do not expose to temperatures over 25°C. Keep well away from direct sunlight and heat sources. Keep tightly sealed.

SECTION 8: EXPOSURE CONTROL / PERSONAL PROTECTION

Stability: This material is stable under normal conditions

Conditions to Avoid: Avoid heat, flame, sparks, and direct sunlight. Lower flash point requires extra vigilance around heat sources.

Hazardous Decomposition By-products: Smoke and unidentified organic compounds may be formed during combustion.
