Inhalation: If inhalation causes irritation, supply fresh air. Royal Rose is a rich, complex oriental rose fragrance — use in well-ventilated areas at appropriate concentrations. Generally regarded as calming and well tolerated.

Ingestion: Rinse out mouth and drink plenty of water. Seek medical attention immediately.

SECTION 4: FIRST AID MEASURES

Eyes: Flush with plenty of water or eyewash solution for 15 minutes. Get immediate medical attention.

Skin: Remove contaminated clothing. Wash with soap and flush with plenty of water. Seek medical attention if irritation or allergic reaction persists.

Ingestion: Administer water or milk to dilute. Seek medical attention immediately or call a poison control center.

Inhalation: Remove to fresh air. Seek medical attention if needed.

SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal Protection: Avoid ingestion. Follow good industrial hygiene practices. Wear eye protection, gloves and aprons. Ventilate area well.

Methods for Cleaning Up: Eliminate all sources of ignition. Ventilate area. Prevent liquid from entering sewers.

- Small spills: wipe up with paper rags or absorb with inert material (place in closed waste container)
- Large spills: absorb onto non-flammable absorbent. Wash area with soap and water. Dispose per local regulations.

SECTION 7: HANDLING AND STORAGE

Safe Handling: Avoid ingestion. Follow good industrial hygiene practices. Wear eye protection and gloves. Always dilute before topical application — recommended 1–3%. Due to the exceptional richness and tenacity of the agarwood and guaiacwood base, use the drop-by-drop technique — a very small amount delivers powerful fragrance impact. This is an alcohol-free, phthalate-free premium fragrance oil.

Storage Requirements: Store in a cool, dry, and well-ventilated area. Do not expose to temperatures over 25°C. Keep tightly sealed in dark glass containers away from light and heat to preserve the characteristic complex rose profile. Shelf life up to 3 years when properly stored.

SECTION 10: STABILITY AND REACTIVITY

Stability: Stable under normal conditions. The agarwood (oud) and guaiacwood base components act as natural fixatives enhancing stability. Keep tightly sealed to preserve the complex rose and woody character. Shelf life up to 3 years when properly stored.

Incompatibility (Materials to Avoid): Avoid contact with strong oxidizing agents and avoid hot ignition sources near empty containers.

Conditions to Avoid: Avoid contact with sparks, flame, heat and direct light.

Hazardous Decomposition By-products: Smoke and unidentified organic compounds may form during combustion.

Hazardous Polymerization: Will Not Occur

SECTION 11: TOXICOLOGICAL INFORMATION

Sensitization: Contains citronellol and geraniol — both listed as EU-declarable fragrance allergens (REGULATION (EC) No 1223/2009, Annex III). May cause allergic contact dermatitis in sensitive individuals. Use at recommended dilution levels (1–3% topical).

Risk Phrases: Mildly irritating to eyes and skin (if used undiluted). May cause sensitization by skin contact (citronellol, geraniol). Citronellol and geraniol are EU-declarable fragrance allergens. Toxic to aquatic organisms with long-lasting effects.

Safety Phrases: Avoid contact with eyes. In case of contact with eyes, rinse immediately with water and seek medical advice. Dilute 1–3% before topical application. Declare citronellol and geraniol on EU cosmetic labels above threshold concentrations. Keep out of reach of children.
