SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

Eye Contact: Irritation will occur with possible damage

Skin Contact: May cause irritation upon prolonged exposure. Contains aroma chemicals which may cause sensitisation — patch test before first skin application.
