SECTION 4: FIRST AID MEASURES

Eyes: Flush with plenty of water or eyewash solution for 15 minutes. Get immediate medical attention.

Storage Requirements: Store in an area that is cool, dry, and well-ventilated. Do not expose to temperatures over 30°C. Keep away from direct sunlight to preserve the fresh strawberry and creamy character. Keep tightly sealed.
