### SECTION 3: HAZARD IDENTIFICATION

The toxicological properties of this material have not been fully investigated.

**Eye Contact:** Irritation will occur with possible damage

**Skin Contact:** May cause irritation upon prolonged exposure. Contains aroma chemicals which may cause sensitisation — patch test before first skin application.

**Inhalation:** If inhalation causes irritation, supply fresh air. Avoid concentrated inhalation; use in well-ventilated spaces.
